## **Our Commitment**

DaDa is committed to protecting your privacy and holding information securely. This policy explains how and why we collect and use personal data. Our aim is to ensure you remain informed and that you are in control of the information we hold about you. We will never sell your personal data, and will only ever share it with organisations we work with where necessary and if its privacy and security are guaranteed.

#### **About Us**

Personal data will be collected and used by DaDa – Disability and Deaf Arts (DaDa) (charity no. 1014390 in England). We care about your privacy and the security of your personal data. By personal data we mean any information which identifies you, or which can be identified as relating to you personally.

#### What Information we collect

#### Personal data you provide

We collect data you provide to us. This includes information you give us when you attend an event, participate in one of our activities, make a charitable donation or communicate with us. This information may include:

- personal details such as name, date of birth, email, address, access needs, telephone etc.;
- financial information including payment information such as credit/debit card or direct debit details, and whether donations are gift-aided. If you decide to donate to us then we will keep records of when and how much.
- details of your interests and preferences (such as particular types of event you have attended or why you support DaDa)

## <u>Information created by your involvement with DaDa</u>

Your activities and involvement with DaDa will result in personal data being created. This could include details of how you've helped us by volunteering or being involved with our campaigns and activities.

## <u>Information we generate</u>

We occasionally conduct research and analysis on the information we hold, which can in turn generate personal data. For example, by analysing your interests and involvement with our work we may be able to build a profile which helps us decide which of our communications are likely to interest you.

## Information from third parties

We sometimes receive personal data about individuals from third parties. For example, if we are partnering with another organisation to develop or host an event or activity.

We may collect information from social media where you have given us permission to do so, or if you post on one of our social media pages.

## Sensitive personal data

We do not normally collect or store sensitive personal data but there are some situations where this will occur (e.g. if you volunteer with us, if you participate in one of our programmes). Where this does occur, we'll take extra care to ensure your privacy rights are protected.

#### Accidents or incidents

If an accident or incident occurs on our property, at one of our events or involving one of our staff (including volunteers) then we'll keep a record of this (which may include personal data and sensitive personal data).

#### Volunteers

If you are a volunteer then we may collect extra information about you (e.g. references, criminal records checks, details of emergency contacts, medical conditions etc.). This information will be retained for legal reasons, to protect us (including in the event of an insurance or legal claim) and for safeguarding purposes.

#### **How we will use information**

We only ever use your personal data with your consent, or where it is necessary in order to:

- enter into, or perform, a contract with you;
- comply with a legal duty;

- protect your vital interests;
- for our own (or a third party's) lawful interests, provided your rights don't override the these.

In any event, we'll only ever use your information for the purpose or purposes it was collected for (or else for closely related purposes):

# Marketing

We use personal data to communicate with people, to promote DaDa and to help with fundraising. This includes keeping you up to date with our news and activities.

From 25 May 2018 DaDa has asked its supporters to "opt-in" to receive communications including all our marketing communications. This means you'll have the choice as to what you want to receive and how you are happy to receive it

You can decide not to receive communications or change how we contact you at any time. If you wish to do so please contact via one of the methods outlined above.

#### Administration

We use personal data for administrative purposes (i.e. to carry on our charity work). This includes:

- receiving donations (e.g. direct debits or gift-aid instructions);
- maintaining databases of our volunteers, participants and supporters;
- helping us respect your choices and preferences (e.g. if you ask not to receive marketing material, we'll keep a record of this).

## Internal research and analysis

We may carry out research and analysis on our supporters, donors and volunteers, to determine the success of campaigns and appeals, better understand behaviour and responses and identify patterns and trends. This makes us a more effective organisation and helps us provide you with a better experience (e.g. through more relevant communications).

## **Disclosing and sharing data**

We will never sell your personal data or pass it on to a third party without your consent.

If you have opted-in to marketing, we may contact you with information about our partners, or third party products and services, but these communications will always come from DaDa and will usually be contained within our own marketing materials

Occasionally, where we partner with other organisations, we may also share information with them (for example, if you register to attend or participate in an event being jointly organised by us and another organisation). However, this will be done

under an agreement which imposes strict requirements on our partner to keep your information confidential and secure.

## **Fundraising**

As a charity, we do sometimes request donations from others to support our work. We'll only contact you specifically about fundraising if you've opted into to receiving this information from us (and you can, of course, unsubscribe at any time).

## **Research and Profiling**

We may aggregate and anonymise personal data so that it can no longer be linked to any particular person. This information can be used for a variety of purposes, such as recruiting new supporters, or to identify trends or patterns within our existing supporter base.

This information helps inform our actions and improve our campaigns, products/services and materials.

## **Young People**

We take great care to protect and respect the rights of individuals in relation to their personal data, especially in the case of children.

If a young person is under 18, we'll only use his or her personal data with parental consent and we won't use young people's personal data for marketing purposes or profiling.

#### **How we Protect Data**

We employ a variety of physical and technical measures to keep your data safe and to prevent unauthorised access to, or use or disclosure of your personal information.

Electronic data and databases are stored on secure computer systems and we control who has access to information (using both physical and electronic means). Our staff receive data protection training and we have a set of detailed data protection procedures which personnel are required to follow when handling personal data.

DaDa is based in the UK and we store our data within the UK. Some organisations which provide services to us may transfer personal data outside of the EEA, but we'll only allow them to do if your data is adequately protected.

#### **How long we store information**

We will only use and store information for so long as it is required for the purposes it was collected for. How long information will be stored for depends on the information in question and what it is being used for. We continually review what information we hold and delete what is no longer required.

## **Your Rights**

We want to ensure you remain in control of your personal data. Part of this is making sure you understand your legal rights, which are as follows:

- the right to confirmation as to whether or not we have your personal data and, if we do, to obtain a copy of the personal information we hold (this is known as subject access request);
- the right to have your data erased (though this will not apply where it is necessary for us to continue to use the data for a lawful reason);
- the right to have inaccurate data rectified;
- the right to object to your data being used for marketing or profiling; and
- where technically feasible, you have the right to personal data you have provided to us which we process automatically on the basis of your consent or the performance of a contract. This information will be provided in a common electronic format.

Please keep in mind that there are exceptions to the rights above and, though we will always try to respond to your satisfaction, there may be situations where we are unable to do so.

## What is a cookie?

We use various technologies on our site to collect information that helps us improve your online experience. We refer to these technologies which include cookies, collectively as "**cookies**". This Cookie Policy explains the different types of cookies used on our site and how you can control them.

A cookie is a small file of letters and numbers that we store on your browser or the hard drive of your device. Cookies are widely used throughout the Internet in order to make sites or other online services work or to be better or more efficient. They can do this because sites and other online services can read and write to the cookies stored on your device, enabling them to recognise you and remember important information that will make your use of them more convenience, for example, by remembering your preferences, username, or showing you pages that you seemed to have a particular interest in.

If you consent to us storing cookies on your computer or other electronic device then you agree that we can store and access cookies as described in this policy.

#### How you consent to us placing your cookies

When you visit our site you should see an overlay at the bottom of your screen directing you to this Cookie Policy and our Privacy Policy.

## **Google Analytics**

The cookies used by Google Analytics are used to collect information about how you use our site. We use this information to compile reports and to help us improve our site. # **How do I control cookies?**

#### **How long is cookie information stored?**

Different cookies may be stored for different periods of time. It is important to understand that when a cookie is placed on your computer it will reside on your hard drive until it expires and is deleted or it may reside on your hard drive until you manually delete it – this entirely depends on your individual browser settings and we do not have control over this.

Please remember that you can delete or change the way in which you store cookies on your computer at any time.

#### **Changes to our cookie policy**

We may need to change this Cookie Policy if it's necessary for legal reasons or to reflect changes to our services or the purpose for which we use cookies. In any case, the provisions of this Cookie Policy may be changed without prejudice to your rights.
